#### **COOPERATIVE AGREEMENT**

THIS AGREEMENT made and entered into this 13 day of November, 2020, by and between MILESTONE ENGINEERING, INC., hereinafter referred to as the "Engineer", and GREENE COUNTY, MISSOURI, hereinafter referred to as "County":

#### WITNESSETH:

WHEREAS, the Engineer is currently serving as a representative for the Burlington Northern Santa Fe Railroad (BNSF) and is employed to act as a project manager overseeing the administration and inspection of contracted construction work on behalf of BNSF for the installation of a new railroad siding track and a new railroad bridge adjacent to Farm Road 193 and Farm Road 199 in southeast Greene County, and

WHEREAS, the Engineer acknowledges that it is necessary to perform certain pavement repairs along Farm Road 193 and Farm Road 199 in order to address damages that have occurred to the County's roadway system by BNSF's contractor's work vehicles and heavy equipment during the construction of the new railroad siding track and the new railroad bridge adjacent to these public roadways, and

WHEREAS, the County and the Engineer are in agreement that conducting certain pavement repairs to improve and preserve the County's public roadway system along Farm Road 193 and Farm Road 199 is in the best interest of both parties, and

WHEREAS, both the County and the Engineer desire to make a financial contribution towards the costs associated with repairing and restoring the roadway pavement along Farm Road 193 and Farm Road 199:

NOW, THEREFORE, the parties do hereby mutually covenant and agree as follows:

- 1.) PAVEMENT REPAIR WORK BY THE ENGINEER: The Engineer shall administer and oversee a construction contract for the purpose of performing pavement repairs to Farm Road 193 and Farm Road 199. These pavement repairs will include cold milling of the existing bituminous roadway wearing surface, construction of a 1-inch asphalt wedge to level the existing travel lanes, and the construction of 1.75-inches of asphalt overlay to resurface approximately 10,400 linear feet of the County's aforementioned roadways. The total estimated cost for these pavement repairs is \$221,192.32. The asphalt pavement repair work will be on South Farm Road 193 and South Farm Road 199 from a point beginning on the north end of South Farm Road 193 where it intersects with East Farm Road 148 (East Old Sunshine Road) continuing south and east along South Farm Road 193 to where it intersects with South Farm Road 199 and continuing north along South Farm Road 199 to a point of intersection where Greene County maintenance ends and MoDOT maintenance begins.
- 2.) REIMBURSEMENT OF COST BY COUNTY: Following completion of the pavement repairs specified in Paragraph 1, the Engineer shall submit to the County invoices, checks, or other evidence of all costs incurred for the pavement repairs to Farm Road 193 and Farm Road 199, whereupon the County agrees to reimburse the Engineer for such costs within 30 days of receipt of such

documentation, provided however, the amount of reimbursement to be paid by the County shall not exceed \$84,000.

- 3.) RIGHT OF WAY USE: The County agrees to grant Engineer and its contractor a temporary license for access to the public right-of-way of Farm Road 193 and Farm Road 199 as is necessary for the construction of the pavement repairs defined in Paragraph 1. The Engineer shall require its contractor to obtain and comply with the County's right-of-way permit requirements. The Engineer's contractor shall not perform any work on the County's right-of-way until a right-of-way permit has been approved by the County to authorize these repairs on Farm Road 193 and Farm Road 199. All work on Farm Roads 193 and 199 by the Engineer and its contractors shall be performed in a workman like manner and in compliance with acceptable governmental and industry road standards.
- 4.) INDEMNIFICATION: The Engineer acknowledges and agrees that the County is not, and shall not be, in any way liable for damages or injuries that may be sustained as a result of the County's approval of the pavement repairs defined in Paragraph 1, or as a result of the County's issuance of any approvals, permits, certificates, or acceptances of any improvements to Farm Roads 193 and 199. The County's issuance of any such approvals, permits, certificates or acceptances does not, and will not, in any way be deemed to insure the Engineer, nor any of its contractors, or any third party, against damage or injury of any kind at any time. The Engineer further agrees to defend, hold harmless and indemnify the County, and all of its elected officials, officers, employees, agents, engineers and attorneys, from any and all claims, losses, damages, liabilities, judgments and expenses, including attorneys fees and court costs, whether based on a claim for damages to real or personal property or to a person including personal injury or death, for any matter that may be asserted at any time against any such County, its officials and employees, including, but not limited to the County's approval of the pavement repairs defined in Paragraph 1; the County's issuance of any approval, permit or certificate for the pavement repairs defined in Paragraph 1; the construction of any of the roadway improvements defined in Paragraph 1 by the Engineer or any of its contractors or agents; the performance of the Engineer of its obligations under this Agreement including, but not limited to, any acts of negligence or wrongful conduct on the part of the Engineer, its agents, contractors, or employees, and performance by the County of its obligations under this agreement. The engineer will require any contractor procured by the Engineer to perform work under this agreement to carry Commercial General Liability Insurance and Commercial Automobile Liability Insurance from a company authorized to issue insurance in Missouri, and to name the County and its elected officials and employees as additional named insured in an amount sufficient to cover the sovereign immunity limits for Missouri public entities (\$500,000.00 per claimant and \$3,000,000.00 per occurrence) as calculated by the Missouri Department of Insurance, Financial Institutions ad Professional Registration, and published annually in the Missouri pursuant to Section 537.610, RSMo. In no event shall the language of this agreement constitute or be construed as a waiver or limitation on County's rights or defenses with regard to its applicable sovereign, governmental or Official immunities and protections as provided by Federal and State Constitutions, statutes and laws.
- 5.) **ASSIGNMENT**: Greene County shall not assign any interest in this contract, and shall not transfer any interest in the same (whether by assignment or novation), without the prior written consent of the Engineer thereto.

- 6.) **ENTIRE AGREEMENT**: This agreement contains the entire agreement of the parties. No modification, amendment, or waiver of any of the provisions of this agreement shall be effective unless in writing specifically referring hereto, and signed by both parties.
- 7.) **JURISDICTION**: This agreement and every question arising hereunder shall be construed or determined according to the laws of the State of Missouri. Should any part of this agreement be adjudicated, venue shall be proper only in the Circuit Court of Greene County, Missouri.
- 8.) INDEPENDENT PARTIES: The County and the Engineer who are parties to this agreement are each separate and independent, and nothing contained herein shall constitute or designate Greene County, or any of Greene County's contractors, agents, or employees as agents or employees of the Engineer. The County and the Engineer shall each retain their own independent identity and each is responsible for its own policies and activities. This agreement shall not be construed as creating a joint venture between the County or the Engineer.
- 9.) **DISCRIMINATION**: Greene County agrees in the performance of this contract not to discriminate on the ground or because of race, creed, color, national origin or ancestry, sex, religion, handicap, age, status as a protected veteran or status as a qualified individual with a disability, or political opinion or affiliation.
