9-1-1 Advisory Board Meeting February 15, 2023

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Moore on February 15, 2023, via phone conference call. Seven board members were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –January 18, 2023 Meeting Minutes Moore indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Denison motioned to approve the minutes; Pennington seconded. Motion carried 7/0.

3. STATUS UPDATES

Financial Reports - The written report for the December Financials were presented by Deputy Budget Officer Tina Phillips. December represents 100% of the year. Sales tax ended the year strong at 18.77% over budget. 911 Service Charge at 89.75% and bank interest at 138.66% compared to budget. Overall, revenue finished the year at 119.28% or \$1,582,877 over budget. Personnel expenditures were 98.32% with vacancy at \$88,805.55 better than budget of \$275,000. Operations came in under budget at 93.24%. When you combine Personnel and Operations, total expenditures finished the year at 97.35%. Capital, Debt Service and Contingency finished at 63.94%. Overall, total expenditures came in below budget at 94.39%. When making adjustments for one-time expenses (Gen.Liability, Telephone, Spfld All OvrHd, CAD System Main, Equipment), expenses are 94.38% of budget. Adjusted YTD Overall Budget is \$7,175,844 and Adjusted Overall YTD Spending is \$6,772,522 for a \$403,322 volume to the good through 12 months.

Cash balance at the end of December 2022 was \$6,777,249.46 in the warrant account. This is \$2,245,239 higher than last year. Cash level is 4.07 times the required operating reserve level of \$1,665,031.
